In ye name of god Amen, To all Christiane Peple. greeting Know yea that I william Halliok (of this Towne) being through gods blessing of Sound memory and in good health of body doe Constitute ordaine and declare these presents to bee my Last will and Testament In maner and form as followeth.

Lastly: my will is that my beloved wife Margaret Halliok bee and hereby I Doe apoint her the Sole Executrix of this my last will and testament and I doe desire my two neighbors James Reeves and Calleb Horton to be Assistants to my Executrix with there best Advice and Councell about Such matters as Shee Shall think meet to Advise with them alsoe my will is that all my debts and funerall Charges be payd by my Executor out of Such Stock of Cattle horse and swine as I leave with her before that Shee devides them to my three Sons (vizt) thomas peter and william also my will is that my Son John Halliok whom as an obstinate apostate I Doe Reject and deprive of all other Estate yet I Doe Hereby give unto him his heires and Assignes forever my Second Lott at ye wadeing Creeke with the Apurtenances thereunto belonging which is all that hee is Ever to have of my Estate and in Confirmation that these presents are my Last and Irrivocable will I have this tenth of february in 34 year ye Rain of our Sovereigne Lord king Charles ye Second Sett her unto my hands and Seale.

"p. 10-11. "WILLIAM HALLOCK who died Sept. 29, 1684, son of Peter Hallock, made a will which is preserved in the ancient records both of Suffolk Co. at Riverhead and of New York city. It is dated "Southold (township) Feb. 10, 1682," and was proved Oct. 21, 1684. "I commit my soul into the hands of Jesus Christ my gracious Redeemer, and my body to the earth by decent burial, in assured hope of the resurrection at the last day."

He gives his property to his wife Margaret, his four sons, THOMAS, PETER, WILLIAM, and JOHN, and his five daughters, Margaret, Martha, Sarah, Elizabeth and Abigail. "The land where I now dwell at Aquebogue" (near Mattituck) and the lane dividing it, he wills to Thomas and Peter giving Thomas the western half "except the swamp lot" near his house; and giving Peter the eastern half with "the swamp lot" and his dwelling. To his son William he gives lands in or near Southold village, and to his son John, land in Wading River.

The will implies deep sorrow that his son John had married into and joined the then proscribed Society of Friends, and has the proviso that if any one of his sons "shall apostatize from the Protestant doctrine and faith: or " willfully and of set purpose contemn and neglect the public worship of God suitable therto," what is here willed to him shall pass over to "the next lawful heir that shall steadfastly profess and own the said doctrine and faith."."

The Daughters of William2 Halliok/Hollyoake

Jack E. Phillips, Sr.

In an effort to clarify apparent discrepancies in the list of daughters of William2 Halliok/Hollyoake (c. 1610-1684), as explained below, this searcher would like to enlist the aid of others with knowledge of additional sources. The sources used in this discussion are as follows:

- (1). The Hallock Ancestry, for the Memoir of Rev. Jeremiah Hallock of Connecticut and Rev. Moses Hallock of Massachusetts, 1863; apparently the work of William A. Hallock, Senior Secretary of the American Tract Society. A ten-page (unnumbered) pamphlet (EHFL)*

"The will of William halliok (c. 1610-1684) recorded in source (6) was dated February 10, 1682 and proved October 21, 1684. That portion pertaining to his daughters, copied November 14, 1990 by this searcher, is as follows:

gly: My will is that ye firs yeare After my wives desease my son Thomas and Peter shall eaach of them pay or Cause to bee payd unto my daughter Mary the sum of five pounds In Currant pay of this place and Each year following they shall pay Each of them five pounds to Each of my other Daughters according there age that is to say the second yeare after my wives death1 to martha five pounds: apiece ye third yeare they shall Each of them pay five pounds apiece to sarah2 the fourth year After my wives death Each of my said sons shall pay five pounds to Abigaile apiece to Elizabeth and the fifth yeare they shall pay Each of them five pounds to Abygaile my youngest daughter all ye these payments to be in Currant pay of this plyee place.

The Hallock genealogies sources (1) through (4) show the five daughters of William 2 Hallock (c. 1610-1684) as: Margaret, Martha, Sarah, Elizabeth and Abigail. That sequence is maintained in each source from 1863 to 1928, as follows: (1) pg. 2, (2) pg. 390, (3)pg 7, (4) pg 11, 533, apparently as listed in his will. In source (4) pg. 621 the sequence changes with Elizabeth listed first, for which an explanation is given in source (5) pg. 156-7; the explanation being that Elizabeth was his daughter by a previous marriage in England, and that she came to America with her father. No mention is made of a daughter Mary.

The recording of the will in source 6 pg. 158 lists his daughters as: Mary, Martha, Sarah, Elizabeth and Abigail (Abygaile). As can be seen from the above excerpt, the will contains a schedule of payments to be made by his sons Thomas and Peter to these five daughters after his wife's death. Of these five daughters names only Sarah is unclear, running off the page. There is no doubt in this searchers mind as to the spelling of daughter Mary's name. This is confirmed by source (7) pg. 129, with corrections in source (8) pg. 14, which is presumably taken from another early recording of the will in New York City. No mentoin is made of a daughter Margaret.

The key wording in the excerpt of the will appears to be that payments are to be made to the last four daughters "according there age"; with the schedule indicating that Elizabeth was the second from the youngest. This conflict with source (5) which indicates that Elizabeth was by a previous marriage making her the oldest. Assuming the latter source to be true, the possibility of two daughters Elizabeth, one by each marriage, arises.

Note that John Hallock is on the same page with him, no other Hallock's listed, implying John oldest son, first married son ?? . Note that Will Hallock had among the highest tax base of anyone in Southold, and, with 70 acres, was among the largest landholders in Southold. Note also, insofar as livestock goes, he was primarily into swine, whereas Barnabas Horton was primarily into sheep. Note also it appears "head" means "house". Most others only had "one" head. Implying 2 kids had built homes on his property by now?? nmt."

Will: William Hallock referred to his wife as "Margaratt hallyok", in his 1682 will.

May be a Widow Howell: Note that there is a 1675 real estate deed in which William Hallock refers to Richard Howell as "son-in-law", but in the 1600's this term included step-sons, which could mean that William Hallock's wife was Richard Howell's mother (not his sister, as indicated by the Hallock Genealogy). It could also mean step-son in the sense that we use the term today. If this is so, and if Richard was a son of the wife of William Hallock, it suggests that Richard's wife in 1675 is from an earlier wife of William Hallock, ie a step-brother married step-sister.

Furthermore, it should be noted the records do not indicate which daughter of William Hallock is the wife of Richard Howell. Tradition holds it was Elizabeth, but this is not proven. (He is without a wife in the 1698 census, but had married the widow Elizabeth (___) Cooke, between Nov 1684 - Dec 1685. This indicates whoever the first wife of Richard Howell was did not mother all of his children, and had died before 1684. That wife could have been any of William Hallock's daughters - if he was a "son-in-law" in the sense we use the term today. The identity as her as Elizabeth probably comes from records showing he had a wife named Elizabeth, but that would be the second wife, Elizabeth (Cooke) Harrud.

Tradition: The tradition reported over the years is that Margaret Howell and Richard Howell were siblings and children of the "Widow Howell", who married their step-father, Peter Hallock. The tradition continues that Margaret (___) Howell married William Hallock, and that Richard Howell married William and Margaret's daughter: Elizabeth Hallock. This would mean that Richard married his niece, an unlikely scenario. It is much more likely that William married a widow and referred to Richard Howell as son-in-law.

1698 Census: A Margaret Hallock, presumably the wife of the immigrant, William Hallock, is in the 1698 census in the household of Joseph Reeve, his wife Abigail, and their children. This entry gives rise to the conjecture that William Hallock's daughter Abigail is this wife of Joseph Reeve.

Death: 9 May 1707 "Margaret Hallock dead wid" (Salmon Records)."
